"5. The special provisions are: 1. Commercial purposes, if any, included in the articles are intended only to advance or support one or more of the non-profit purposes of the corporation. No part of a corporation's profits or of its property or accretions to the value of the property may be distributed, directly or indirectly, to a member, a director or an officer of the corporation except in furtherance of its activities or as otherwise permitted by the Ontario Not-for-Profit Corporations Act.
2. Upon the dissolution of the corporation and after satisfying the interests of its creditors in all its debts, obligations and liabilities, its remaining property shall be distributed to the Canadian Association of Municipal Administrators.
3. The corporation is authorized to establish two classes of members: "Active Members" and "Associate Members". The rights, privileges and restrictions attaching to the Active Member and Associate Member classes of membership are as follows:
(i) Active Members shall be entitled to receive notice of, attend, and vote at all meetings of members, and each Active Member shall be entitled to one (1) vote at such meetings.
(ii) Associate Members shall be entitled to receive notice of and attend all meetings of members, but shall not be entitled to vote."
