Eligibility

To be considered to receive a JIC Award, a Sisterhood Affiliate must fulfill each of the following for each of the 3 fiscal years (FY 2024, 2025 and 2026) since the last JIC Award.

- Pay WL per capita annually
- Financially support the annual Torah Fund Campaign with a Sisterhood Affiliate donation and/or member donations
- Financially support Masorti Women's Days of Study, for 2026 only, with a Sisterhood Affiliate donation and/or member donations, including those made on Giving Tuesday
- Attend a Region Conference and/or Region meetings/events
- Participate in or sponsor at least 2 programs in each of the following categories

- Education, Environment Sustainability
- Social Action, Israel, World Affairs
- WLCJ Engagement
