What will happen next

The date that your trade mark will be advertised as accepted will be after 09 May 2023. Once the required time has elapsed, IP Australia will send you an acceptance notice detailing when your trade mark will be advertised as accepted and the two month opposition period will begin.

The earliest a trade mark can proceed to registration is seven and a half (7.5) months after the filing date. Therefore there may be a waiting period between acceptance and registration.
