Candidates may submit with the nomination form a head and shoulder photograph and a statement limited to 300 words (words in excess will be deleted from the end of the statement). Only statements which comply with the Rules and are received by the Returning Officer by (Australian Eastern Standard Time (AEST)) on 05/08/2024 can be accepted.

Withdrawing Nominations

Nominations cannot be withdrawn after 4:00pm Australian Eastern Standard Time (AEST) on 12/08/2024.

Voting Period

The ballot, if required, will open on 21/08/2024 and close at 10:00am Australian Eastern Standard Time (AEST) on 18/09/2024.
