# **Annual Assessment**

Moss Creek is unique in many ways. As a Member, you have access to all of the amenities in the Community which includes two golf courses, seven tennis courts, four pickleball courts, boat storage including boat slips, two dry storage areas, kayak storage, two nature preserves, a beautiful Clubhouse, the casual waterfront Bostwick Pavilion and Bostwick Point Park, a dog park, a magnificent Fitness and Pool Complex, and miles of leisure trails. All amenities are maintained and funded in part by the Annual Assessment, which also helps fund the operating and capital expenses of the Community.

#### **Every property owner in Moss Creek pays the Annual Assessment, which for 2025 is either:**

Improved Property: \$8,112 - or - Unimproved Property: \$6,726

\*This fee can be paid in full by January 31, 2025 or billed in twelve equal monthly payments. (\$676.00 improved or \$560.50 unimproved)

# Activity Fee - \$1,600

This is an optional fee. Every Member is entitled to use the Moss Creek amenities, and is encouraged to enjoy them. Your choice is to either pay the **Annual Activity Fee** or pay the respective Daily Fees to use the amenities.

The Annual Activity Fee is a <u>per household fee</u> and includes the Member, Spouse/Partner, and dependent children living in the home under the age of 25. The Activity Fee is non-refundable, and expires with the sale of property. It is not transferable.

- Unlimited Golf (excludes cart fees)\*
- Unlimited Range Usage
- Unlimited Tennis Court Usage
- Unlimited Pickleball Court Usage
- Access to wet/dry slips \*\*+
- Access to kayak storage, bag storage, locker rental, golf and racquet 10-round guest passes and golf and racquet guest fees at a reduced price+
- \* Activity Fee required for purchase of annual cart plan
- \*\* Activity Fee required for use of wet/dry slip and additional fees apply depending on size of slip and storage options.

#### **Sales and Admission Taxes**

Except where noted, all fees are subject to applicable state sales and admission taxes.

#### **Boating**

All wet and dry slip assignments require an Activity Fee, slips are assigned based on availability. **Effective January 1, 2025, each household is permitted to have one space (i.e. either a wet or dry slip). Households with more than one slip have until March 31, 2025 to reduce down to one space. This is contingent upon a full audit/confirmation of the waitlist.**
