We invite scholars, practitioners, and researchers to contribute to "Accounting through the ages: Lessons for modern challenges," a conference that bridges our rich accounting heritage with contemporary challenges. While papers will be accepted across the full range of accounting history topics and methodological and theoretical perspectives, authors are encouraged to address topics relevant to the conference theme.

- Past resistance to accounting innovations: lessons for adopting new technologies today

- Evolution of fraud detection: insights from historical cases for modern forensic accounting
- Corporate social reporting through the ages: lessons for current sustainability frameworks
- Development of non-financial metrics: historical perspectives on measuring social impact
- Evolution of accounting education: historical foundations for future professional development
- Gender, diversity, inclusion and equity in accounting: historical barriers and lessons for current challenges
- Accounting as a control and surveillance mechanism through history
- Colonial influences on accounting systems: implications for modern international standardisation
