B. REQUIRED ATTENDANCE

- Five sessions held once per month on the 2nd Friday of each month: June 9, July 14, August 11, November 10 and December 13. Times vary, and will take up approximately ³/₄ of the day.

- Participants will graduate upon completion of a minimum of five sessions. Class members are required to attend the Introduction Day on June 9.

C. CONFIDENTIALITY STATEMENT - During sessions, cell phone use and texting is not permitted. We allow many breaks for participants to conduct business. To give full attention to important speakers we ask that you do not disrupt the session.
