- 1. Please create an account in School & Student Services (SSS) and complete the Parent Financial Statement (PFS), including income and expenses projections for 2020
- 2. Documentation: Please upload the following documents to the Document section in SSS: 2018 taxes with all accompanying schedules, 2018 W-2s (for both parents, if applicable), and the **Tuition Assistance Request Form for 2020-2021**
- 3. Complete the COVID-19 Emergency Consideration Form (below)
- 4. Email the form, including all required documentation to communitysupport@agnesirwin.org
- 5. You will receive an email within 24 hours that your application for consideration is complete

Please plan to complete this process, as outlined above, no later than <u>Wednesday, May 13</u>
<u>2020</u>. Notification to families will be prior to the end of May 2020.
