

CIRCLE F DUDE RANCH CAMP MINOR RELEASE AND WAIVER

NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF CIRCLE F DUDE RANCH CAMP, LLC USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CAN NOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM CIRCLE F DUDE RANCH, LLC, AND ITS OWNER, AFFILIATES, EMPLOYEES, AND AGENTS, IN A LAWSUIT FROM ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND CIRCLE F DUDE RANCH LLC, AND ITS OWNERS, AFFILIATES, EMPLOYEES, AND AGENTS, HAVE THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

Natural/ Legal Guardian: I am aware and understand that some of the activities at Circle F Dude Ranch Camp LLC involve potential risks of physical injury and I understand that the programs are physically demanding and present inherent risks and danger of unanticipated physical injury, emotional distress, and/or property damage. These activities include, but are not limited to: Odyssey high ropes course, rock climbing and zip lines; alpine tower; swimming; horseback riding; paintball; off-property excursion; waterfront activities (blob, banana boat, summit, sailing, canoeing, etc.); wilderness programs; skate park; evening programs; horsemanship; general sports (tennis, softball, volleyball, soccer, archery, cheerleading, tumbling, dancing, etc.); etc. (hereinafter referred to as the "Activity" or "Activities"). I am aware and understand that all of the program Activities are strictly voluntary and it is my choice as the Parent /Legal Guardian's to allow participate in each activity to whatever degree as a Parent /Legal Guardian deem appropriate, after due consideration of my child's own physical health, physical abilities and medical condition. I further state that in choosing to participate.

In exchange for allowing my minor to participate in the activities, I personally hereby knowingly and intentionally release, disclaim and waive any and all rights relating to , and covenant not to sue, Circle F and its parents, affiliates, subsidiaries, shareholders, members, managers, directors, officers, employees, representatives, attorneys, agents, successors and assigns (collectively, "Released Parties") concerning any and all liability, judgments, demands, claims causes of action, damages, obligations, costs and expenses (including, without limitation, reasonably attorney' fees) arising out of and/or relating to any risk, harm, damages or injury (including, without limitation, personal injury, including death, and injury to property) that my minor or any third person might incur or suffer, directly or indirectly as a result of my minor engaging in the activities and/or the risks that are a natural part of the activities; provided, however, this release, waiver and covenant do not apply in the event any liability, judgments, demands, claims causes of action, damages, obligations, costs and expenses (including, without limitation, reasonably attorney' fees) are caused by the tortious conduct of the Circle F or any of the released parties.
