## *i*-Ready

## **Reading and Math Online Instruction**

- Given the extraordinary situation unfolding across the country, we have extended i-Ready Instruction – our online lessons in Reading and Math – to over 1 Million students at NO CHARGE through June 2020.
- Unlike typical implementations of *i-Ready*, which require students to take the i-Ready Diagnostic before beginning instruction, we have made it possible for teachers to assign i-Ready lessons to students WITHOUT an assessment.
- Participating schools will need to meet a set of requisites designed to help us reach as many students as possible in a timely manner. Please consider the following requirements:
  - 1. Extended i-Ready access may be added for all students in the school for desired grades and subjects. You may offer instruction for as many grade levels as you need, K-8, for reading, mathematics, or both.
  - 2. We will need direct access to leaders in your school who manage technology, student information systems, professional development, and curriculum to effectively launch the program.
  - 3. All students and teachers in the participating schools must be rostered by Curriculum Associates.
  - 4. All classroom teachers will need to attend a virtual training session that will instruct them how to assign and monitor the most appropriate i-Ready lessons for their students.
