Your child has the opportunity to participate in the Adventure Challenge Program at Bryn Mawr Mountain Retreat & Conference Center in Honesdale, PA. There are inherent risks in these activities. Bryn Mawr's staff will make every effort to minimize risk through proper instruction, guidance, and supervision of these activities. Possible risks include but are not limited to: personal injury, emotional distress, loss or damage of personal property, and potential death.

I understand that participation in the Adventure Challenge Program will involve varying levels of physical activity. My child is in good physical health and has no known physical condition which would require him/her to refrain from participation in any activity.

All persons or organizations associated with such activities will save and hold harmless Bryn Mawr Mountain Retreat & Conference Center from same, including cost of defense attorneys fees. I am fully aware of the risks, inherent dangers, and need of good physical health, and I am assuming them on behalf of my child. It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, can only be brought in the 22nd Judicial District of the Court of Common Pleas of Wayne County located in Wayne County Pennsylvania, and shall be construed in accordance with the laws of Pennsylvania.
