1	Enforcement of Section 41.18 that prohibits sitting, lying, sleeping, and storage of personal property near sensitive uses such as schools, day care centers, public libraries, public parks, an alcoholism or drug abuse recovery or treatment facility, or permanent supportive housing.	Yes	Enforcement of 41.18 around these sites are not discretionary and is simply the law. If we are to fully address the homeless crisis, we have to focus on getting people off the streets and inside so they get the care they need, not just pushing people from one street corner to another.
2	The ordinance adding Section 56.15.3 to the Los Angeles Municipal Code designed to stop the proliferation of open-air bicycle “chop shops,” (spaces on public property where individuals dismantle stolen bicycles and sell their parts or reassembled bicycles).	Yes	I am opposed to bicycle theft and believe the police should enforce existing laws to address bicycle theft.
7	To protect our tree canopy, a motion (in the future) to enact laws that require discretionary approval of the removal of more than one tree per a 12-month period on private property that is more than 8” in trunk diameter.	Yes	Discretionary approval is not enough protection for trees and setting the threshold for protecting trees at 8” may not do enough to protect certain kinds of trees.

13	A policy that would cause a bus-only lane or protected bike lane to result in eliminating the number of vehicle lanes.	No, but will work with communities to design safe biking routes	It depends on the street and the research findings of the Los Angeles Department of Transportation (LADOT), one cannot have a blanket policy.
